Consideration of Application

- 1. The Panel considered the papers, which included, an application to change the Licence Holder (LH) and minutes of the Shrewsbury and Telford Hospital NHS Trust Board Meeting held on 27 October 2011. In this case the Trust Board had requested that it assume the responsibilities of the LH.
- 2. The Panel noted that the previous LH had left the Trust last summer and consequently there was not a letter of resignation for it to consider.
- 3. The Panel noted it was in receipt of a signed application form and that Board meeting minutes served as written confirmation from the proposed LH, accepting the role for this centre.
- 4. The Panel noted that the role of Medical Director would assume direct responsibility on behalf of the Board. Dr R Ashley Fraser is currently the Medical Director at this centre.
- 5. The Panel noted the Inspectorate's recommendation to approve the application for the change of LH.
- 6. The Panel agreed that it was satisfied regarding the suitability of the proposed LH.
- 7. The Panel confined its consideration to the evidence before it.

The Panel's Decision

- 8. The Panel agreed to vary the licence to make the Medical Director of Shrewsbury and Telford Hospital NHS Trust Board the Licence Holder, in accordance with section 18A of the HFE Act 1990 (as amended).
- 9. The Panel specified that the Licence Holder is identified as the post holder of Medical Director who is currently Dr R Ashley Fraser. The PR should inform the HFEA if the post or person is changed in the future.
