## 1. Consideration of application

- 1.1. The panel considered the papers, which included a statement from the current Person Responsible (PR) explaining the issues with the submission of an application form, an executive summary, previous licensing minutes, a CV and confirmation of acceptance from the proposed Person Responsible (PR).
- 1.2. The panel noted that the proposed PR, Mr Cesar Diaz Garcia, is willing to assume the responsibility of the role of PR. The panel noted that the proposed PR has satisfactorily completed the PR Entry Programme (PREP) and the certificate number was provided.

## 2. Decision


