• Members of the panel declared that they had no conflicts of interest in relation to this item.

The panel had before it:

- 9th edition of the HFEA Code of Practice
- Standard licensing and approvals pack for committee members.

1. Consideration of application

- **1.1.** The panel considered the papers, which included an application form, an executive summary, previous licensing minutes, a CV and confirmation of acceptance from the proposed Person Responsible (PR).
- **1.2.** The panel noted that the proposed PR, Dr Mathew Tomlinson is willing to assume the responsibility of the role of PR. The panel noted that the proposed PR has satisfactorily completed the PR Entry Programme (PREP) and the certificate number was provided.
- 1.3. The panel noted that Dr Mathew Tomlinson has suitable qualifications for the role of PR.
- **1.4.** The panel noted from the information provided that the character, qualifications and experience of the proposed PR, Dr Mathew Tomlinson are suitable to carry out a PR's duties under section 17 of the HFE Act 1990 (as amended).
- 1.5. The panel noted that there is one outstanding non-compliance from the interim inspection, conducted at the centre in January 2018. This relates to the storage of the centre's liquid nitrogen tank at a distance from the cryostore that exceeds recommendations of the British Compressed Gas Association for the movement of heavy pressurised vessels. Appropriate action was taken to reduce the risk of movement in the short term and an application for the relocation of the cryostore at the centre is in progress, which will fully resolve this non-compliance.
- 1.6. The panel noted that all information required under General Directions 0008 has been provided.
- **1.7.** The panel noted the inspectorate's recommendation to vary the centre's licence to appoint Dr Mathew Tomlinson as the PR.

2. Decision

- **2.1.** The panel agreed it was in receipt of the appropriate documentation as required by the HFE Act 1990 (as amended) in relation to Section 16(2), which sets out the requirements with regard to the role of Licence Holder and Person Responsible.
- **2.2.** The panel endorsed the inspectorate's recommendation and agreed to vary the licence of the Queens Medical Centre Fertility Unit (centre 0162) with immediate effect to reflect the change of Person Responsible to Dr Mathew Tomlinson in accordance with Section 18A of the HFE Act 1990 (as amended).
